It may also be noted that UGC has proposed to link "AADHAAR" with students bank account so that there can be direct cash transfer and effective disbursal of fellowship into bank account of the student. In this regard Secretary, UGC has already requested the universities to help students in Aadhaar enrolment vide his D.O. No. F,14-34/2011




